Lake Carolina Release and Waiver of Liability, Assumption of Risk and Indemnity, and Parental Consent Agreement

NOTE: If you are under the age of 18 a parent/guardian must be present at the event and sign this form in order for you to participate. If you are 18 years of age or older you will need to sign the waiver below in order to jump.

In consideration of participation in the Lake Carolina Polar Bear Plunge, I represent that I understand the nature of the event and that I/or my minor child am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I/ or my minor child believes event conditions are unsafe, I and/or my minor child will immediately discontinue participation in the Activity.

I fully understand that the Polar Bear Plunge event involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions or inactions those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my minor child incur as a result of my and/ or my minor child's participation in the Activity.

I hereby release, discharge, and covenant not to sue Lake Carolina Development, Southern Community Services, Lake Carolina Properties, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and/or the owners of the premises on which the activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses or damages on my account and/or that of my minor child caused or alleged to be caused whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my and/or my minor child's behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE OF WAIVER AND LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, AND PARENTAL CONSENT AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
